NOTICE OF BIDDERS' CONFERENCE AND PROPOSED AMENDMENTS TO THE DRAFT REQUEST FOR PROPOSALS IN RESPECT OF THE ROUTE OPERATOR LICENCES IN THE EASTERN CAPE ("DRAFT RFP")

Notice is hereby given that a Bidders' Conference for the Draft RFP has been scheduled for 10h00 on Thursday, 18 June 2026 at the offices of the Eastern Cape Gambling Board (ECGB), ECGB Building, Quenera Park, Quenera Drive, Beacon Bay, KuGompo City, Eastern Cape.

The purpose of the Bidders' Conference shall be to consider issues raised in the written comments to the Draft RFP issued by the Board in April 2026, to clarify matters that Prospective Bidders may raise, and to answer any questions from all interested parties in preparation for the final RFP.

Attention of Prospective Bidders is drawn to the essential minimum requirements of the Draft RFP which are available on the ECGB's website (www.ecgb.org.za).

Admission to the Bidders' Conference is at an amount of R3,200.00 and will be limited to five (5) delegates per Prospective Bidder with respect to in person attendees.


This notice further advises of the ECGB's intention to amend the Draft RFP issued in April 2026 to make available three (3) Route Operator Licences instead of the two (2) Licences provided for in the Draft RFP, for the roll-out of the available 2700 Limited Pay-out Machines (LPMs) in the Eastern Cape Province. Each of the three (3) Route Operators will be allocated a maximum of 900 LPMs for rollout in Phase 1. The remaining 100 LPMs per Route Operator, to reach the maximum of 1000 LPMs will be rolled out in Phase 2 during the roll-out of the remaining 3000 LPMs of the 6000 LPMs allocated to the Eastern Cape Province.
